INDEPENDENT AUDITOR'S REPORT

on the Public Benefit Simplified Annual Report submitted for the forthcoming Board Meeting of the Budapesti Fesztiválzenekar Alapítvány

To the Board of Trustees of the Budapesti Fesztiválzenekar Alapítvány

Opinion

We have audited the public benefit simplified annual report of Budapesti Fesztiválzenekar Alapítvány (the "Foundation") for the year 2016 which comprise the balance sheet as at December 31, 2016 (which shows an equal amount of total assets and total liabilities of thHUF 1,532,012 and an after-tax loss for the year of thHUF 128,021), as well as the related profit and loss account for the year then ended and the notes to the public benefit simplified annual report including a summary of significant accounting policies.

In our opinion, the public benefit simplified annual report s give a true and fair view of the financial position of the Foundation as at December 31, 2016 and its financial performance for the year then ended in accordance with Act C of 2000 on Accounting effective in Hungary and the Government Decree No. 224/2000 (XII.19.) and accounting principles generally accepted in Hungary.

Basis for the opinion

We conducted our audit in accordance with the Hungarian National Standards on Auditing and the effective Hungarian laws and other regulations on audits. Our responsibilities under these standards are further described in the "The auditor's responsibilities for the audit of the public benefit simplified annual report" section of our report.

We are independent of the Foundation in compliance with the Hungarian ethical requirements pertaining to our audit of the simplified annual report, and we have fulfilled our other ethical responsibilities in accordance with the same ethical requirements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of management and those charged with governance for the simplified annual report

Management is responsible for the preparation and fair presentation of the public benefit simplified annual report in accordance with the Account Act and with the Government Decree No. 224/2000 (XII.19.) and accounting principles, and for such internal control as management determines is necessary to enable

the preparation of public benefit simplified annual report that are free from material misstatement, whether due to fraud or error.

In preparing the public benefit simplified annual report, management is responsible for assessing the Foundation's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Foundation or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Foundation's financial reporting process.

The auditor's responsibilities for the audit of the simplified annual report

Our objectives during the audit are to obtain reasonable assurance about whether the public benefit simplified annual report as a whole are free from material misstatement, whether due to fraud or error, and to issue, on the basis of the above, an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with the Hungarian National Standards on Auditing will always detect a material misstatement when it exists. Misstatements can arise from fraud or error, and they are considered material if, individually or in the aggregate, they could reasonably be expected to influence the economic decisions of users taken on the basis of these simplified annual report.

As part of an audit in accordance with the Hungarian National Standards on Auditing, we exercise professional judgment and maintain professional scepticism throughout the audit. We also:

- Identify and assess the risks of material misstatement of the public benefit simplified annual report, whether due to fraud or error, design and perform audit procedures responsive to those risks, and obtain audit evidence that is sufficient and appropriate to provide a basis for our opinion. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control;
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Foundation's internal control.
- Evaluate the appropriateness of accounting policies used and the reasonableness of accounting estimates and related disclosures made by management.

Our conclusions are based on the audit evidence obtained up to the date of our auditor's report. However, future events or conditions may cause the Foundation to cease to continue as a going concern.
- Evaluate the overall presentation, structure and content of the public benefit simplified annual report, including the disclosures, and whether the public benefit simplified annual report represent the underlying transactions and events in a manner that achieves fair presentation.

Accounting policies

Basis for the accounting policies of the Budapest Festival Orchestra Foundation (hereinafter referred to as: Foundation):

- Act C of 2000 on Accounting, and
- Government Decree No. 224/2000 (XII.19.) on the reporting and bookkeeping obligations of other organisations as provided for in the Act on Accounting
- Government Decree 350/2011 (XII.30) on the financial management of foundations
- Act CLXXV of 2011 on Non-Profit Organisations
- Act V of 2013 on the Civil Code of the Republic of Hungary.

General provisions in accounting policies:

- bookkeeping method:

double entry

The accounting records must be kept in a way that separates the Foundation's business income and expenses (costs) from its non-profit income and expenses (costs), in order to ensure a reliable reporting-year result for the organisation.

type of annual report:

simplified non-profit annual report

- reporting date:

31 December 2016

- balance sheet preparation date:

31 March after reporting date of financial year

The Foundation discloses and publishes its annual reports on its website – www.bfz.hu – while they can also be inspected at the registered office.

The Foundation must be audited in accordance with Government Decree 224/2000 (XII.19.).

Filing and publishing

The Foundation must file and publish the Annual Report approved by the competent body, the Non-Profit Supplement and the Independent Auditor's Report by the last day of the fifth month after the reporting date for the given financial year. This filing and publishing requirement must be fulfilled in accordance with Sections 39-40 of the Act on Judicial Procedures, which means the Annual Report must be sent to the National Office for the Judiciary electronically.

The Foundation has its own website, which means the publication obligation also includes placing the annual report and the non-profit supplement on the website. The published data must be permanently accessible on the organisation's own website at least until the figures on the second financial year after the given publication are disclosed.

Significant errors

An error is significant if, in the year when discovered by any form of audit, the total of all errors (whether negative or positive) for a given financial year (separately for each year) and the impacts thereof—increasing or decreasing profit/loss or equity—exceeds the threshold set forth in the accounting policies. Errors shall be construed as significant in all cases if, in the year when discovered by audit, the aggregate amount of all errors (whether negative or positive) for the same year and the impacts thereof—increasing or decreasing profit/loss or equity—exceeds 2 (two) percent of the balance sheet total of the audited financial year, or HUF 1 million, if 2 percent of the balance sheet total does not exceed HUF 1 million.

Provisioning

Provisions must be allocated as required against the pre-tax profit for payment obligations to third parties derived from past or present transactions or contracts which, on the reporting date, are expected or certain to arise, however, their amount or the date of occurrence are uncertain and the entity has not provided for them in any other way. When allocating provisions, liabilities prevailing on the reporting date must still be taken into consideration even if they only became known between the reporting date and the balance sheet preparation date.

Allocation of costs and expenses

The Foundation allocates its costs and expenses to non-profit and business activities if such can be clearly allocated; in the event it cannot be clearly identified which activity the given cost or expense relates to, the costs and expenses are distributed in proportion to income.

There were no material changes to the accounting policies in the reporting year.

The figures in the Foundation's simplified annual report are stated in thousands of forints.

Valuation methods

Valuation of foreign currency and exchange items

The Foundation proceeds as follows to determine the forint value of currency reserves, FX on account, receivables, investments and securities denominated in foreign currency (collectively: foreign currency assets) and FX liabilities:

- Foreign currency and exchange are converted into forints using the mean of the account-holding bank's buying and selling rates.
- The foreign exchange rate defined above shall not be used for the conversion into forints of any non-convertible currency, or of assets and liabilities denominated in such currency, which are listed neither by banks nor by the National Bank of Hungary. In these cases, the foreign currency must be converted into forints at the free-market rate.

If the difference between the book value before the reporting date valuation and the HUF value as of the valuation date of foreign currencies in petty cash, foreign exchange on account, FX receivables, investments, securities and liabilities

- a) is an aggregate loss, it must be accounted for as an exchange loss under other expenses on financial transactions,
- b) is an aggregate gain, it must be accounted for under other income on financial transactions.

Valuation of assets

Fixed assets and current assets are measured at cost net of any depreciation.

If the market value of an asset is lower than its book value at the reporting date of the financial year, the difference shall be settled as extraordinary depreciation or impairment.

Any reversals of extraordinary depreciation or impairment shall be carried out during the valuation as of the balance sheet reporting date for the financial year.

Depreciation of assets

Annual depreciation shall be planned with regard to the useful life of the individual asset, its physical wear and tear and market obsolescence, as well as to the circumstances typical of the

given activity, and after being recorded shall be applied from the date of first use or capitalisation. Depreciation follows the straight-line method.

3. NON-PROFIT SUPPLEMENT

1.) Presentation of reporting-year activities by basic purpose and non-profit activity

With 148 concerts in Hungary, 40 concerts abroad and more than 50 youth productions in a year, the Budapest Festival Orchestra is the country's leading and busiest orchestra. Aside from traditional concert-hall concerts it also frequently performs community concerts in schools, nursing homes, orphanages, hospitals and other special venues – thereby bringing the magic of music to a broad audience. In 2015 a new project entitled DancingOnTheSquare was launched. This programme provides regular activities for several hundreds of underprivileged children living outside Budapest for a period of six months. The project also conveys the objective of building a community through music and dance as well as advocating the idea of tolerance. Another novelty from the orchestra is the autism-friendly Cocoa Concerts that also address children from underprivileged backgrounds and their families.

2.) Presentation of non-profit activities:

The aim of the Foundation is to run the Budapest Festival Orchestra to increase awareness of and foster Hungarian music culture – with particular regard to promoting the highest standard of musical life in Budapest and representing Budapest and Hungary abroad as an ambassador for Hungarian culture – as well as create the conditions required for the operation of the Orchestra.

• Main results of non-profit activity:

The most important aim of the BFO is to bring music closer to people. This applies in the same way to the greatest concert stages in the world as to chamber concerts held in abandoned synagogues and churches all over the country, performances at schools and in nursing homes or Cocoa Concerts given in Mindszent or Cserdi. We strive to share an unforgettable experience with as many music lovers and socially disadvantaged people as possible. The Festival Orchestra played concerts in 2016 on 188 occasions in total, thereby reaching 127,365 people worldwide.

I. Hungary's leading symphony orchestra:

On 31 January the crème de la crème of Hungarian music gathered to highlight as many exciting excerpts from German Romanticism as possible at the traditional concert **Marathon**. Besides Kristóf Baráti, Katalin Kokas, Barnabás Kelemen, Dénes Várjon and Anna Lucia Richter, the list of performers this time included among others the Hungarian National Philharmonic Orchestra, the Pannon Philharmonic Orchestra, the MÁV Symphony Orchestra and the Budapest Strings Chamber Orchestra. The marathon was concluded as is customary by the Budapest Festival Orchestra and conductor Iván Fischer, with a special performance of *A Midsummer Night's Dream* including theatrical elements. During the one-day event more than 10,000 people listened to the amazing compositions of the two German composers.

The Festival Orchestra closed its summer season with a concert featuring Mozart's The Magic Flute as well as some of the works from his last year, including Requiem and Clarinet Concerto in A major. Following the Budapest performances the orchestra conducted 7 concerts within 10 days in 4 major European cities: London, Bruges, Baden-Baden and Amsterdam. The Bruges concert was broadcasted live by the TV channel Mezzo, so the musical experience reached 28 million homes worldwide.

The Palace of Arts and BFO transferred pieces of France to Budapest at their traditional season-opening **Bridging Europe festival** between 21 and 28 September. The organisers are convinced that trust and friendship among European nations is very much in demand, and art is the perfect way to strengthen this. "Being part of a European family means that all people are equally important, equally loveable and have equal opportunities. There is no distinction between nationalities, religions, skin colours or origin. We are all humans, members of one family." (Iván Fischer)

In the 2016-17 season Iván Fischer will provide three composers close to the Budapest Festival Orchestra with an opportunity to introduce themselves to Hungarian audiences while conducting the BFO. In November, Gergely Dubóczky had his debut, while in April, Victor Aviat from France and Australian Vladimir Fanshill will step onto the stage in the Academy of Music. Iván Fischer, BFO music director, summed up the essence of the concert series as follows: "I can still vividly remember the feeling when I was first thrown in at the deep end a couple of decades ago. It was a great help that I saw friendly, helping eyes among the audience. So please smile for these young talents."

In 2016 the Festival Orchestra visited **venues outside Budapest** on 55 occasions, of which 8 concerts were organised by Philharmonia Hungary. In addition to international-standard concert halls (e.g. Pécs) the orchestra also performed in smaller towns, theatres, schools and community halls, such as in Kaposvár, Nagykanizsa, Nyíregyháza, Cserdi, Tiszaszalka, Sellye, Bonyhád, Bátaszék, Téglás or Komló.

The majority of the concerts in Budapest and the tour performances abroad were conducted by Iván Fischer, music director and artistic director of the Orchestra. Yet this year again, other

world-famous conductors and soloists also played together with the orchestra, e.g. Midori Seiler, Jörg Widmann, Gábor Takács-Nagy (first guest conductor), to mention but a few.

II. Cultural ambassador of Hungary:

The orchestra achieved great international success in May with Mozart's The Magic Flute: 'What creativity, what richness!' - said one of the reviews. According to the article, the performance of The Magic Flute boasted many witty, even sublime moments. "Mozart's message clearly indicates that music is unifying and timeless, while Iván Fischer is one of the most inspiring ambassadors of that idea in the world today.' In June, the orchestra played on the Stars of the White Nights festival in the recently renovated concert hall of the Mariinsky Theatre in St. Petersburg with the help of the Ministry of Foreign Affairs and Trade. "When the orchestra stood up and started singing in Russian you could have heard a pin drop from the astonishment, but then came the audience's ovation.'

In July, the orchestra was honoured with a **shower of international awards**, receiving two distinctions from The Association of Music Critics of Argentina. Iván Fischer was awarded the Best Foreign Conductor Award, while the Festival Orchestra received the honours of Best Foreign Symphony Orchestra. Besides the Argentinian awards, following its concert in the Carnegie Hall in February, the BFO was included on the highly-respected list of the New York Observer that collects the most defining moments of classical music in the last six years. The reason given was that from all the performing orchestras, the BFO was the one able to create "the most unique sound and temperament on stage". Furthermore, the Festival Orchestra was included on two top lists of the British Gramophone magazine; the recording of Mahler's Symphony No. 4 is listed among the 10 best Mahler Symphony albums, and the recordings of Beethoven's Symphonies No. 4 and 6 secured their places on the list of the 50 Best Beethoven CDs. BBC Proms is the most popular and the largest classical music event in the world, and BFO is a returning guest. The Telegraph awarded 5 stars to the performance of the orchestra in August.

III. Orchestra for the community:

Through its community and educational programmes the Budapest Festival Orchestra constantly strives to deliver the beauty of classical music to all ages and segments of society. The orchestra connects people through the power and charm of music, building and reinforcing communities. Between 17 and 23 April the BFO organised its 5th Community Week. During the one-week event, chamber formations of the orchestra played music in a total of 21 locations. from Komló in Baranya county to Téglás in Hajdú-Bihar county. The aim of the Community Weeks is to create opportunities for people to meet classical music who would otherwise not have the chance to get to a Budapest concert hall on their own: the elderly, for whom the sound of a violin is sometimes the best medicine, underprivileged youth living outside Budapest, children with reduced mobility, church communities, residents of small towns and villages. In April the orchestra visited the Synagogue in Karcag, the Protestant church in Komló, the SOS Children's Village in Orosháza and several nursing homes for the elderly among others. Between 15 and 24 June the community-building activities continued with new concerts. During the Community Week they performed for one Catholic and two Reformed church communities, in Pannonhalma they joined the Saint Martin Year events, to Sellye they invited the entire Ormánság region and they held a concert in Hódmezővásárhely too. The first venue of the Synagogue Concerts was Mátészalka, followed by Bonyhád, where they played in one of the first Hungarian synagogues that was still used as paint warehouse just a few years ago. The concert series ended in Kunszentmárton in one of the masterpieces of Hungarian Secession architecture which, despite operating as a granary and furniture warehouse for some 25 years, now serves as a cultural centre. Our interactive-integrating youth concert entitled Music Castle was performed during this Community Week to the great enjoyment of the children of Bódvaszilas, Tiszaszalka and Told. In Told the BFO played for the underprivileged children of the "Igazgyöngy" Foundation, whose director Nóra L. Ritók said the following about the initiative: "Music is able to lift these multiply disadvantaged children into wonderful places, where there is joy, childish purity and harmony... where there are no social differences. Where you are simply a human being. A person of possibilities. Classical music is able to open this gate. The gate of the soul. 'In addition, the musicians of the Festival Orchestra performed chamber concerts in 12 retirement homes from Budapest through Csókakő to Csongrád.

IV. Orchestra for children and youngsters:

The Festival Orchestra places great emphasis on the music education of young people. To this end it launched its **partner school programme** in 2012. Such partnerships are open and free for any school. Presently, the BFO cooperates with more than 50 partner schools offering programmes like A Taste of Musical Instruments, Rehearsal Visits, children's opera performances brought to schools, or master courses. Thanks to the active engagement of teachers and music teachers as well as the tireless work of the BFO musicians, several thousands of pupils visit the BFO rehearsal hall in Óbuda every year, and the orchestra goes to partner institutions more than 60 times a year. Musical encounters of teachers are made possible by the Teachers' Café launched in 2014. The orchestra arranged a special concert form for autistic children and young people in collaboration with the "Nemzetközi Cseperedő Alapítvány" foundation.

Nearly 5000 young dancers, 6000 km travelled, 6000 spectators – huge crowds were curious to see the **DancingOnTheSquare** event of the Festival Orchestra on Heroes' Square in 2016 too. The children, mostly from disadvantageous backgrounds, became real heroes for one day: they could show their talent, their perseverance, and the overwhelming power of joint creation. Underprivileged children shared a common goal, and had the uplifting experience of tolerance and respect towards each other. In cooperation with its partner DIA (Foundation for Democratic Youth) the BFO organised a summer camp in Hollókő for the youngsters participating in the project.
